The alternate member is a non-resident and per the Board's Policy on Appointments to Boards, Committees & Commissions, "non-residents may be appointed to a non-binding committee and the appointment will be to an alternate position for a one (1) year term."

b. <u>Discuss the 2017 Type III Ambulance Bids</u> (10 minutes) – In the 2016-17 budget, we set aside \$220,000.00 for a Type 1 Ambulance. In December, 2016, we received five bids for this purchase, ranging from \$240,695.00 to \$263,504.09. All bids received were over budget. After evaluating the bids, Chief Rowe recommended to the Board at the December 13th meeting to reject all bids, reconfigure our bid specification packet and send this back out to bid in hopes of coming within budget.

In December, new bid specifications were sent out for a Type III Ambulance (a Type III ambulance has a pass through to the back of the ambulance from the cab and a Type I ambulance does not). We received the following three bids for this purchase:

The Fire Chief recommends purchasing the ambulance from Autotronics at a price of \$219,155.00 and the "On Spot" Chain option of \$2,950.00, which was inadvertently omitted in the rebid bid specifications, totaling \$222,105.00.

e. <u>Hear Selectmen's Comments Regarding the January 17th Joint Meeting with the Kennebunk Light & Power District Regarding the Dams</u> (10 minutes) – At the January 17, 2017 joint meeting with the Kennebunk Board of Selectmen the Kennebunk Light and Power Trustees, the future of three dams along the Mousam River were discussed. At the request of Chairman Richard Morin, Selectmen are provided this opportunity to offer their perspective of said meeting.

a. <u>Discuss the 2017 TIF Operational Expenditures</u> (10-15 minutes) – At the Board's last meeting, the recommendations from the Downtown Committee, Lower Village Committee, West Kennebunk Village Committee and Economic Development Committee (EDC) were presented for the 2017 TIF District projects and expenditures.

Since the last meeting, the EDC has met and supports the funding of the Regional Economic Development Corporation. Additionally, the committee would prefer the TIF fund 50% of the Economic Development Director position with the balance funding through the regular operating budget.

Attached is a breakdown summary of the 2017 TIF District projects and expenditures for your review.

9. New Business (1st Reading)

a. <u>Discuss the Donation of a Fire Department ATV</u> (5-10 minutes) – The Kennebunk Fire Rescue (KFR) was fortunate to have one of the first and perhaps the only ATV in the area many years ago. This unit was gifted to the Fire Department from the ladies' auxiliary. For many years, it served the department well and mutual aid departments relied on the KFR for off road service with this machine. Since then, most departments have acquired their own units. Over the years, KFR received another donated ATV and purchased a new unit in 2013.

Our current ATV machine count is three. Chief Rowe would like to reduce the inventory. He asked if any other Kennebunk Department would be interested in either of the two machines they are seeking to take out of service. No department has indicated a desire for either of these machines, which are older units. Parts for these aged machines are becoming increasingly difficult to acquire.

The two machines the Chief intends to take out of service are a 1998 Yamaha Big Bear 4x4 with a small trailer and a 1999 Polaris Big Boss 6x6. He would like to donate one of the machines to the

Town of Arundel, specifically to the fire rescue division. Arundel does not own this type of machine and have attempted, unsuccessfully, to obtain one. They would respond with it to our community if we were in need of its use. They also have a large portion of the Eastern Trail in their community and this would greatly assist with coverage for that trail network. The other unit will be sold in the next surplus bid process.

MOTION: To approve the transfer of the 1998 Yamaha or 1999 Polaris ATV to the Town of Arundel at no cost, and to place the other ATV out to bid.

- b. <u>Discuss Road Closures for Special Events</u> (15 minutes) The Special Event Policy requires Board approval for road closures. The following Special Event Applications have been received and will require road closures, per the Police Department, as noted below:
 - Maine Coastal Marathon Sunday, May 14, 2017
 Fletcher Street closed from Ross Road to Main Street 7:15 a.m. 7:45 a.m.

A "rolling road closure" (a section of road that closes then re-opens as the event progresses) is required for this event and will affect one lane of the following roads from 7:15 a.m. to 9:40 a.m.:

- Summer Street
- Port Road
- Western Avenue
- Lower Sea Road/Beach Avenue

MOTION: To approve the road closure as recommended by the Police Department for the Maine Coastal Marathon on Sunday, May 14, 2017 as noted above.

• Music on Main – Portland Symphony Orchestra – Thursday, August 3, 2017 According to the Police Department, the same format for the Main Street road closure used for the last two years would be applied. In the past, there were no accidents, delays or reported issues during these events.

The Portland Symphony Orchestra will be playing at the Waterhouse Center starting at 6:00 p.m. The following road closures will be in effect from 5:30 p.m. through 8:15 p.m. +/-.

- 5:30 p.m. Main Street will be closed at Fletcher Street directing cars toward Mechanic Street as a part of the detour south for Rt.1. Detoured cars can go onto Mechanic Street then left onto Storer Street toward Main Street/Rt. 1 south.
- 5:30 p.m. Main Street will be closed at Water/Storer Streets. Cars traveling north on Rt. 1 will use Water Street to Factory Pasture Lane, left onto Depot Street then left onto Summer Street. From Summer Street they will turn north onto Portland Road/Rt. 1 north.
- Internal closures on Main Street: Barricades will be placed across Main Street at Bourne Street and by Grove Street. Additional barricades will be placed across Main Street by the crosswalk next to Garden Street.
- Note: Grove Street will remain open. One way traffic will be allowed to go across Main Street starting from the parking lot behind Perfecto's Cafe. Cars can go onto Garden Street or Curtis Court. No cars will be allowed to cross Main Street to go toward Grove Street.
- All streets may be reopened once pedestrian foot traffic has cleared.
